**Red Palm Weevil, *Rhynchophorus Ferrugineus*
(Olivier) in Malta**

According to Part V (Containment and Eradication of Plant Pests) of the Plant Quarantine Act, 2001 and Article 6 of the Commission Decision 2007/365/EC on emergency measures to prevent the introduction into and the spread within the Community of *Rhynchophorus Ferrugineus* (Olivier), the whole island of Malta is being defined as a demarcated area for the Red Palm Weevil. This means that movement of susceptible plants, as listed in Article 1(b) of Commission Decision 2007/365/EC, outside the island of Malta to Gozo is being prohibited until further notice.
